Conditions:

In order to qualify for a Landfill charge account you should be utilizing the Landfill at an expense of no less than \$1000 per year. Accounts will be monitored annually and those falling under this amount will have their account closed.

Any business/contractor submitting a charge account application that **does not own land in the City of Weyburn** will be required to put down a \$500 deposit on their account if approved. The deposit will then be refunded to you when you close your charge account.

City of Weyburn Waste Disposal Ground Charge Accounts are invoiced once monthly. All invoices shall be paid accordingly and on time. Failure to do so can result in your charge account being suspended. Failure to make payment after that time may result in the amount owing being applied to your property taxes or your Weyburn business license being revoked.

Please note that any account holder who is delinquent more than twice in one year will have their account terminated.
