#### **ZONING BYLAW**

The purpose of our Zoning Bylaw is to provide predictability and direction in the development of our City. It divides our City into "areas" of development. Each area is then assigned a zone which permits only certain types of development such as residential, commercial or industrial.

IT also regulates the intensity of development such as single family housing or multi-family apartments and sets maximum or minimum requirements for such things as:

- Parking
- Height
- Size restrictions
- · Building Setbacks
- Green Areas
- Fencing
- Visibility
- Grading
- Levelling

The responsibility for compliance with Zoning Bylaw rests with the owner of a property. Failure to comply can have serious and potentially very costly consequences

#### **FENCES & SCREENS**

While a permit is not required for construction of residential fencing, there are some regulations which must be followed when constructing fences or screening in the City of Weyburn. Where shrubs and hedges are used for fencing or screening, please refer to the City of Weyburn Urban Forestry Bylaw for regulations.

Essentially the height of residential fencing is controlled. Maximum height restrictions vary somewhat depending on location and site zoning. In residential zones the maximum permitted height in a rear yard is 2.4 metres or 8 feet. In a front yard area the maximum permitted height is 0.75 metres or 2.5 feet.

The narrower portion of a lot is considered to be the "front" on corner sites. The "front vard area" is the front 7.6 metres or 25 feet of the lot. The "rear yard area" is all of the lot except the "Front yard area"

Probably the best way to ensure that no problems are encountered with regard to your fence location is to keep it within the boundaries of your property.

Contact the Building Department for

information about fencing or screening in zones other than residential. And remember .... Safety first! Always dial 411 before you dig to locate underground utility lines.



#### **BUILDING PERMITS**

The Uniform Building & Accessibility Act of the Province of Saskatchewan is enforced by the City of Weyburn. It adopts a slightly modified version of the National Building Code and establishes minimum structural requirements for new construction. In addition it sets minimum & maximum requirements relating to washrooms in commercial outlets, heating systems and electrical systems, as well as fire and life safety standards in new construction.



Also included is the requirement for the provision of barrier free accessibility (commonly known as wheelchair accessibility) to new public buildings and, in certain situations, when renovations or additions are carried out in residential apartments or buildings used by the public. Building permits are issued as part of the review and approval process. Permits are required for all new construction, additions, decks, garden sheds, satellite dishes, renovation projects and structural changes

#### **NOISE BYLAW**

The City of Weyburn Noise Bylaw is designed to reduce and control both unnecessary and excessive noise which can

cause nuisance and generally reduces the quality and peacefulness of neighbourhoods.

The Noise Bylaw is enforced by Police only when a complaint is made, except when noise originates from moving vehicles.

The most common noise complaints received are noisy parties and barking dogs.

Loud, unnecessary or unusual noise generated from property which disturbs the comfort, and repose of other persons in the vicinity is prohibited at all hours under the Bylaw & Highway Traffic Act.



Disturbing noise from vehicles or properties is prohibited between the hours of 11:00 p.m. and 7:00 a.m.

Anyone found guilty of any infraction of the Noise Bylaw may be fined a minimum of \$100 to a maximum of \$1000.00, Inquiries or complaints should be directed to the Police Department at 306.848.3250.

#### **GENERAL LICENSE BYLAW**

Persons required to be licensed under the provisions of the City of Weyburn's General License Bylaw are those persons carrying on any business, activity, industry, calling or occupation who do not have an assessed business premise within the City of Weyburn.



#### Home Office/Occupation

Any person wishing to conduct an occupation from a dwelling or accessory building must comply with the City of Weyburn Zoning Bylaw regulations for home occupations, and said home occupation requires the approval of City Council. The Planning Department can assist you with this procedure, contact them at 306.848.3221.

#### **Direct Sellers**

In accordance with the Direct Sellers Act, all salespersons acting s as vendor under a direct sales contract, must

obtain a license from the City of Weyburn. Inquires should be directed to the City License Inspector at 306.848.3209.

#### JUNKED VEHICLES

The City of Weyburn has a Bylaw in place to provide for the control of junked vehicles in the City. "Junked Vehicle" means any automobile, tractor, truck, trailer or other vehicle that:

- Has no valid license plates attached to it
- Is in a rusted, wrecked dismantled, inoperative or abandoned condition; and
- Is located on private land, but that is not within a structure erected in accordance with any law respecting the erection of buildings and structures in force within the City; and does not form a part of a business enterprise lawfully being operated on that land.

Notice is served on the owner or occupant of the land to remove the said junked vehicle within 15 days. The owner or occupant is given



an opportunity to show cause why the junked vehicle should not be removed from the land and destroyed or its condition remedied. If the owner or occupant fails to comply with the notice within the time specified by the notice, the owner or occupant is subject to a penalty of up to \$10,000 for an individual or \$25,000 for a corporation. The City will remove the junked vehicle from the land and cost of removing it will be added to the taxes of the property it was removed from. #### **UNTIDY & UNSIGHTLY PROPERTY**

The City of Weyburn has a Bylaw in place to provide for the control of Untidy and Unsightly Property in the City. Notice is served on the owner or occupant of the land or buildings that have been declared untidy or unsightly, and



an order issued to remedy the untidiness and/or unsightliness within 15 days. The owner/occupant is given an opportunity to dispute the order, request further time to comply with the order, or otherwise show cause why the work should not be proceeded with. If the owner or occupant fails to comply with the time specified by the order, the owner or occupant is subject to a penalty of up to \$10,000 for an individual or \$25,000 for a corporation. The City will carry out the work required and costs will be added to the taxes of the property on which the work was completed.

### THE WEED CONTROL ACT

The City of Weyburn, as an Urban Municipality, acknowledges the Government of Saskatchewan's Noxious Weeds Act 1984, commonly referred to as 'The Weed Control Act'.



Hoary Cress

This is a Provincial law to control noxious weeds in residential neighbourhoods and other urban areas, including private and public properties. The City of Weyburn is responsible for administering the control and prevention of any plant species that become established within the boundaries of City of Weyburn and has been declared noxious under "The Noxious Weeds Act, 1984". Briefly, this Act specifies that the control of weeds is the property owner's responsibility and, where there is a problem, the City has the authority to destroy the weeds and collect the cost from the property owner.

The prohibited noxious weeds include Field Bindweed, Leafy Spurge, Bladder Campion, Russian Knapweed, Hoary Cress, and Toadflax. Other noxious weeds that are less difficult to control but a concern when not controlled include Stinkweed, Green Foxtail, Cochia, Dandelions, Sow Thistle, Foxtail Barley, Purple Loose Strife, Russian Thistle, and Barnyard and Couch Grass in lawns.

Presently, the City of Weyburn enforces the Act on a complaint basis and through Citywide surveillance by the Bylaw Enforcement Officer. After receiving a complaint, the Bylaw Enforcement Officer will investigate and respond by serving an order in accordance with The Noxious Weeds Act, which gives specific directions as to what procedures to follow and a reasonable time frame to respond. Failure of the property owner to take corrective measures within the time given will result in the City's Parks Department staff disposing of the specified noxious weeds at the property owner's expense.

This is not a one way street. If you are aware of weed problems on a City property, please let us know so that we can take control measures.

#### DOG AND CAT BYLAW

The City of Weyburn is empowered under *The Cities Act* to regulate and control persons owning or harboring any animal or class of animal within the City of Weyburn.

Bylaw No. 97-1942 regulates and controls the ownership and possession of dogs and cats within Weyburn.

No owners shall permit any dog or cat to run at large in the City. "Run at Large" means not being under control of the owner or any person acting on his or her behalf or by confinement. Any person who owns, keeps, or harbors any dog which by loud and frequent howling or yelping, or any cat which by loud and frequent caterwauling, or in any other manner or way cases annoyance or disturbance to the inhabitants of the City, shall be in violation of the Bylaw.



No persons shall possess or harbor more than three dogs or cats over the age of six months, except for dogs or cats kept in ordinary course of business by the proprietors of a veterinary clinic, boarding kennel, grooming parlor, public pound, pet store or animal shelter. IT is an offence to tease, entice, bait or throw objects at a dog or cat confined within its owner's personal property. Every person having ownership or control of a dog or cat shall immediately remove all excrement left by such dog or cat on any property other than the owner's personal property.

The operation of any kennel within the City shall conform to the City of Weyburn Zoning Bylaw as amended from time to time.

The Weyburn Humane Society is in charge of animal control in the City of Weyburn. Dogs and cats found running at large are delivered to the Weyburn Human Society Animal Shelter at #57 - 16<sup>th</sup> Street NE. If you have lost your animal, contact the Weyburn Humane Society Animal Shelter at 306.848.7387. Impounded animals not claimed within 72 hours may be sold. If not sold after 96 hours the animals may be euthanized.

It is an offence against the Criminal Code of Canada to cause or permit unnecessary suffering or injury to an animal, to neglect a captive or domestic animal, or to encourage the fighting of animals.

#### TRAFFIC BYLAW

Unless otherwise posted, the maximum speed on City streets is 40 km/hr (20 km/hr in lanes).



Traffic Act also apply to bicycles.

The legal speed limit in a school zone is 30 km/hr. *This limit* is in effect 24 hours per day, 365 days per year.

No person shall ride a skateboard on any private property, including any area and its passageways that is intended for the parking of vehicles, without first obtaining permission to do so from the owner of the property. No person shall ride a skateboard on any street or sidewalk in the downtown area between Government Road to 4th Street and Railway Avenue to Coteau Avenue.

The "Rules of the Road" in the Traffic Bylaw and Highway

Hitchhiking is prohibited in City limits.

#### **PARKING**

Vehicles parked in the downtown core receive 2 hour maximum time limit. Parking is enforced regularly by the Bylaw Enforcement Officer and those found to be in violation will be issued a fine.

There are four City owned parking lots in the downtown area at no cost for parking:

- Lot 1 West side of Fourth Street (south of Souris Avenue)
- Lot 2 West side of Fourth Street (north of Souris Avenue)
- Lot 3 East side of Second Street (south of Souris Avenue)
- Lot 4 East side of Second Street (north of Souris Avenue)
- Lot 4A East side of First Street (north side of Souris Avenue)

The intent of free parking in the City is to encourage downtown shopping and accommodate those with appointments.

Vehicles over 6 metres long cannot park on a street longer than one hour. Unattached trailers cannot be parked on streets.

Unauthorized vehicles parking in Reserved Handicapped Spaces is strictly prohibited.

### OPERATION OF CERTAIN VEHICLES IN PARKS, PLAYGROUNDS & PUBLIC RESERVES

No person shall drive or operate a motor vehicle, motorbike, motorcycle, mini-bike, or other like vehicle whether it is licensed or not, or whether it is capable of being licensed or not, on or in any of the following:

- Any boulevard, park or playground within the corporate limits of the City
- Any public reserve either owned or leased and controlled by the City
- Any vacant land owned or leased & controlled by the City within or outside the limits of the City
- Any public parking lot or parking area within the City

This bylaw authorizes City Council to designate areas of land owned or controlled by the City where mini-bikes, bikes and motor bikes may be operated, and these areas are as follows:

- South and west of Terry's Yamaha (517 Government Road South). This area designated for use not later than 8:30 p.m.
- Moffet Pit area located in E½ Section 3-8-14-W2. This area designated for use not later than 9:00 p.m. on weekdays, and shall not be available for use on Saturdays, Sundays, and holidays. Riders desiring to use the Moffet Pit area shall be required to provide the City of Weyburn a Release from all Liability form duly signed by the operator and parent or guardian.

No person shall drive or operate a snowmobile whether it is licensed or not, or whether it is capable of being licensed or not, in any of the following:

- · Street, lane avenue, highway, boulevard, park or playground within the City limits
- Any public reserve either owned or leased and controlled by the City
- Any parking lot, parking area, or vacant land owned or lease by the City, unless the City has given its prior approval to designate a snowmobile trail on the City owned land

The operation of licensed snowmobiles shall be permitted in accordance with the provisions of *The Snowmobile Act 1997*, and between the hours of 7:00 a.m. and 11:00 p.m. on the routes that have been designated as snowmobile routes. Designated snowmobile routes shall be solely used for the purpose of entering and exiting the City limits.

No person shall operate a snowmobile at a speed greater than forty (40) km per hour on the routes. It shall be lawful to operate a snowmobile of the Souris River within the City limits and on the portion of 18<sup>th</sup> Street NE and Moore Street for the sole purpose of crossing these highways at designated areas.

It shall be unlawful for any operator of a snowmobile to cross Provincial Highways 13 and 39 within the City limits, except by the usage of the Souris River at areas designated to do so.

Any Snowmobile unlawfully operated may be seized and impounded. Anyone found guilty of an infraction of the Snowmobile Bylaw may be fined a minimum of \$100. Inquiries or complaints should be directed to the Police Services at 306.848.3250.



#### REFUSE COLLECTION AND DISPOSAL BYLAW

The Solid Waste and Refuse Collection and Disposal Bylaw is designed for the efficient collection and disposal of wastes from all residences and businesses.

The City's residential area is divided into five areas, with one area being picked up each working day. The roll-over system is used when a statutory holiday falls on a work day. All residential areas receive a refuse calendar telling them what day their refuse carts will be emptied. Your cart should be wheeled to the curb prior to 7:00 a.m. to ensure pick up. Overfilled carts or incorrectly placed carts may not be picked up. Inquiries or complaints regarding missed pick-ups or other problems should be directed to the Public Works Department at 306.848.3290.

#### HOURS OF OPERATION AT THE LANDFILL:

Summer Hours (April 1 - October 31): 8:00 a.m. to 6:00 p.m. on weekdays 8:00 a.m. to 4:00 p.m. Saturdays 8:00 am to 4:00 p.m. Sundays CLOSED on stat holidays

Winter Hours (November 1 to March 31): 8:00 a.m. to 5:00 p.m. on weekdays 10:00 a.m. to 4:00 p.m. Saturdays CLOSED Sundays and stat holidays



No delivery shall be made except during the hours of operation as shown here. In case of rainy weather call the Landfill ahead of time to ensure the condition of the road allows for drop off. For further information contact the Landfill Gate Operator at 306.848.3277.

#### HILLCREST CEMETERY

The City of Weyburn operates a municipal Cemetery located o the southern outskirts of the City along Highway 35.



The Cemetery is approximately 24 acres in size and has the capacity for 7,000 interments. It is accessed by using the service road at 10<sup>th</sup> Avenue S. There is a veteran area which was refurbished in 1995 with new concrete runners and grass. The old markers were cleaned and reinstalled, making the area a fitting tribute to those who gave their lives to protect our freedom.

The Cemetery Bylaw and Provincial legislation prohibit certain activities from being conducted in the Cemetery:

- Pets are not allowed in the cemetery
- Children under the age of 14 must be accompanied by an adult
- · Sports activities are not allowed in the cemetery
- No markers, monuments, fences, trees, shrubs, or other such items may be erected or installed or removed except by the City
- Glass displays are not allowed in the cemetery

Hillcrest Cemetery has sections set aside for both traditional casket interments, and in ground and above ground cremations. Hillcrest Cemetery is administered by the Public Works Department at 306.848.3290

#### **URBAN FORESTY BYLAW**

The Urban Forestry Bylaw was implemented in 1988to regulate the planting, maintenance & removal of shade and ornamental trees on public lands and to establish, regulate, & sustain an effective, orderly and healthy Urban Forestry Program.

The Urban Forestry Program is designed to enhance the appearance of the City and promote the welfare of its residents by the establishment and implementation of an Urban Forestry Master Plan, consisting of a master tree plan, a master turf and landscape plan, and a specification/policy manual.

The City of Weyburn acknowledges the fact that trees are very important and represent a valuable resource and economic asset. Trees that grow along the streets, in the parks, cemeteries, school grounds, other public places, and privately owned land, all combine to make up the Urban Forest.



What is the definition of a 'boulevard'? A boulevard is a vegetation strip between a sidewalk and a curb or residential property line. Boulevards are City property and so are the trees growing on them. The trees are maintained by the City's Parks Department. The width of boulevards differs from street to street.

Sight triangle Clearance Restrictions are necessary on all corner lots in residential and commercial zones. A fence, hedge, shrub, or any other plant structure shall not be erected or permitted to grow to a height greater than 0.75m (30") above grade of the streets that abuts the lot within the triangular area bounded by the street lines, the line joining points on the street lines a distance of 7.6, (25') from their point of intersection.

*Note:* Various combinations of basic boulevard designs may exist. If in doubt, please check with the Parks Department at 306.848.3290.

Hedges or shrubs are required to be contained on the owner's property- not overhanging sidewalks or neighbour's driveways. This allows pedestrians to utilize walkways and vehicles to use driveways without restrictions. Shrubs and hedges shall be kept trimmed up to 30cm from the edge of the sidewalk. New hedges shall be planted not closer than 50 cm from a sidewalk.

Who's Responsible for Boulevard Trees? Trees on City boulevards are maintained and controlled by the City. The City is responsible for the care and maintenance of all boulevard trees. You are not allowed to prune or remove City trees. If you do so, you may be liable to a fine/and or damages for the cost of repairing or replacing the tree. Make sure you understand where City property ends and your property begins.\

You can protect our City's trees by watering the trees to help them grown healthy and green. Also, if abnormalities or damages are observed, you should contact the Parks Department at 306.848.3290.



#### FIRE PREVENTION BYLAW

The City of Weyburn Fire Prevention Bylaw is intended to provide for the protection of residents and visitors to our City from the effects of fire. It provides for the enforcement of the Saskatchewan Fire Prevention Act, the Saskatchewan Fire Code Regulations and the National Code of Canada within the City.

The Bylaw provides for the prevention of fires in structures in the City as well as ensuring that structures are designed to limit the spread of fire. Early warning and ease of evacuation from buildings are key elements of the Bylaw. The Bylaw makes it an offence to:

- Park in front of a fire hydrant
- Plant or erect any object within 3 feet of a fire hydrant, or to obscure the view of the hydrant from the street
- Drive over fire hoses
- Light an open fire or burn garden refuse in the City
- Install an indoor or outdoor fireplace without a permit
- Store flammable or combustible liquids indoors



In addition, each home must have at least one operable smoke detector placed between the living & sleeping area. The Bylaw provides for penalties of up to \$5000 for infractions of these and other offences in the Bylaw. Inquiries should be directed to the Fire Department at 306.848.3240.

#### WFYBURN FIRE DEPARTMENT

The Weyburn Fire Department is a combination department with a career Chief and Deputy Chief, career firefighters, and auxiliary (volunteer) fire fighters. Training is conducted every Wednesday evening from the Firehall.

Applications for auxiliary firefighter positions are always welcome and the forms can be picked up at the Fire Hall.



Besides fire incidents, we respond to carbon monoxide alarms, rescue situations, and vehicle accidents.

The Fire department conduct s a comprehensive public education program within the City, including visits to elementary school classrooms, fire extinguisher classes, regular inspection programs, and a review of new construction.

The Fire Department is located at 55- 16<sup>th</sup> Street, and you can reach them at 306.848.3240.

#### WATER & SEWER SERVICE CONNECTION FUND

In 1998, the City of Weyburn implemented a service connection fee to cover the cost of maintenance or replacement of existing water and/or sewer service connections. This monthly fee, which is based on the size of your water service, is included on your water bill.


City's Responsibility The Water & Sewer Service Connection Fund covers the following costs:

- Any maintenance or repair required to the service connection from the center of the street or from the main to a point not closer than one meter from the building foundation.
- Any replacement required to a service connection (of the same size or an old lead water service) from the center of the street or from the main to a point not closer than one meter from the building foundation.
- All plugged sanitary sewers up to two times per year per service, unless it van be shown that the plugged sewer resulted from the owner's negligence, in which case the owner will be responsible for the costs.
- All frozen water services once per year per service (from the main to the building).
- For removing any trees in the boulevard (at the City's discretion) that are an obstruction to the repair or replacement of the water or sewer service.
- For backfilling and initial leveling of excavations related to the water or sewer service repair or replacement.

#### Owner's Responsibility:

- To reseed and re-landscape after backfilling and initial leveling has been carried out by the City.
- Any corrective action required because of settlement on the owner's property.
- Any replacement required to the service connection when water or sewer are upgraded to a larger size or as a
  result of property redevelopment OR any new service connection.

#### PROPERTY MAINTENANCE & NUISANCE ABATEMENT BYLAW

The purpose of the Bylaw is to provide for the proper maintenance of property and the abatement of nuisances, including property or things that affect the safety, health & welfare of people in the neighbourhood or affect the amenity of a neighbourhood. The owner of a property, including land, buildings, and structures is responsible for carrying out the provisions of this Bylaw.

- · No person shall cause or permit a building or structure to deteriorate into a ruinous or dilapidated state
- · No owner or occupant of land shall cause or permit the land to be overgrown with grass or weeds
- No owner or occupant if land shall cause or permit any adjoining boulevards or lanes to be overgrown with grass or weeds
- No person shall cause or permit any land or building to become untidy and unsightly due to the accumulation of new or used lumber, cardboard, paper, newspapers, appliances, tires, cans, barrels, scrap metal or other waste materials or junk
- No person shall keep a junked vehicle on property in the City of Weyburn
- No person shall cause or permit any basement, excavation, drain, ditch, watercourse, pond, surface water, swimming pool or other structure to exist in or on any private land ir in or about any building or structure which is dangerous to the public safety or health
- Pet wastes shall be promptly removed from properties and disposed of in an acceptable fashion. Pet wastes shall not be allowed to accumulate in an unreasonable fashion.



All property including land, buildings and structures, shall be maintained in accordance with minimum standards prescribed in the Bylaw, and no person shall cause or permit the occupancy or use of any property, including land, building or structure, that does not conform to the minimum standards.

## WEYBURN COAT OF ARMS (Since 1967)



The blue shield or our Coats of Arms represents the beautiful blue sky of the prairies and the portion of the Souris River through Weyburn. Our green fields are depicted by the green chevron, and recognition is given to the oil industry with the insertion of the black bars. The backbone of the community is recognized by the gold wheat head. Transportation, industrial development and the railway, to which Weyburn owes its beginning, are symbolized by the gold cogged wheel. Our unique water tower is given a place of honour as it depicts the early structures in our community.

Our pioneering forefathers; whether they were breaking sod, drilling for oil, or constructing road and rail; forged ahead with a vision, applying their natural instincts to overcome the many challenges confronting them beneath the open, blue skies of the prairies. The achievements of our pioneers are reflected in the success our community enjoys today.
