During the month of January 2014 the City of Weyburn issued 7 building permits with a total construction value of just over 2 million dollars (\$2,269,000). Of these 7 permits 2 were for commercial additions for a total construction value of \$713,000; 1 permit of a residential addition with a construction value of \$6,000 and 2 single family dwelling units with a construction value of \$950,000 and 2 new multifamily foundations with a construction value of \$600,000.

In January 2013 we had issued 9 building permits with a total construction value of just under 4 million dollars (\$3,896,000). Of these 9 permits 5 were issued for commercial projects totalling just over 3 million and 2 permits for residential additions with a construction value of \$30,000 and 2 permits for single family dwellings with a construction value of \$841,000.
