## APPLICATION FOR PERMIT TO SELL FAMILY FIREWORKS CONTINUED

IN CONSIDERATION OF THE GRANTING OF THIS PERMIT, I AGREE TO COMPLY WITH ALL THE CONDITIONS OUTLINED IN THIS PERMIT, REQUIREMENTS OF THE FIRE BY-LAW AND ALL OTHER ACTS, REGULATIONS, LAWS, ETC IN FORCE IN THE CITY OF WEYBURN, THE PROVINCE OF SASKATCHEWAN AND CANADA. AND I ALSO SAVE HARMLESS THE CITY OF WEYBURN, ITS EMPLOYEES AND SERVANTS AGAINST ALL CLAIMS, LIABILITIES, JUDGEMENTS, COSTS OR EXPENSES OF EVERY KIND, INCLUDING NEGLIGENCE WHICH MAY ACCRUE AGAINST THE CITY IN CONSEQUENCE OF AND INCIDENTAL TO THE GRANTING OF THIS PERMIT.

- Family Fireworks can only be sold in accordance with **City of Weyburn Fireworks By-Law 2018-3375,**
- Family Fireworks can only be discharged in accordance with **City of Weyburn Fireworks By-Law 2018-3375,**
- Fire crackers or other prohibited items cannot be possessed at ANY TIME in accordance with **City of Weyburn Fireworks By-Law 2018-3375,**
- No Federally, or provincial banned or prohibited products may be sold and all Roman Candles must be sold as part of a packaged family pack
- Inspections will be conducted before granting of the permit to verify compliance with the conditions of your permit to sell fireworks,
- Cannot store more than 1,000 kilograms of fireworks on the premises, including fireworks that are displayed for sale,
- Purchasers of fireworks must verify their age using recognized Federal or Provincial regulated photo identification such as a Passport, Drivers License, Identification Card, etc.
- This permit must be posted in a conspicuous place,
- Permits are valid for one year, effective January 1<sup>st</sup>, continuation of permits require a new application and annual fee,
- An annual fee of \$ 100.00 dollars must accompany this application, and
- Failure to comply with the conditions of this permit may result in:
  - ✓ The Fire Chief or his/her designate may revoke this permit,
  - ✓ The suspension of your business license,
  - ✓ A Peace Officer and /or By-Law Enforcement Officer may lay charges and seize your fireworks, and/or
  - ✓ Upon conviction, your fireworks may be disposed of without compensation,

**AS PER FEDERAL REGULATIONS ALL LOCATIONS MUST HAVE TWO CLEARLY MARKED EXITS FROM THE PREMISE.**
