In order for this petition to be valid, it must be signed by a majority of non-exempt owners and must represent at least one-half of the amount of the special assessments to be raised from the affected lands.

Only owners whose land will be specially assessed for the local improvement may sign. To ensure compliance, please reference the name addressed on the letter of intention mailed to each affected homeowner.

Each person must sign on his/her own behalf. If more than one person is the owner of property, a majority of owners must sign the petition. For example: husband and wife assessed as owners, both must sign the petition; if three different persons are assessed as owners, two must sign the petition. If all owners sign and file with the assessor including a statement that one signature is on behalf of all owners, that signature is valid.

If a person owns more than one lot that will be specially assessed for the local improvement, that person is considered to be one owner only.

No person may add or delete a signature from this petition once it has been filed with the City Assessor.
