BYLAW NO. 2019-3398A BYLAW TO FIX THE RATES OF TAXATION IN THE CITY OF  
WEYBURN FOR THE YEAR 2019

WHEREAS pursuant to Section 253 of the Cities Act a Council shall pass a Property Tax Bylaw annually;

THAT the rates of taxation for the year 2019 for the City of Weyburn, the South East Cornerstone School Division No. 209 (Public School) and the Holy Family Roman Catholic Separate School Division No. 140 (Separate School) shall be as follows:
