

2019 City of Weyburn Utilities Preauthorized Payment Promotional Contest

Official Contest Rules

1. The 2019 Utilities Preauthorized Payment Promotional Contest (“**Contest**”) runs until December 15, 2019 (“**Contest Period**”), with the official draw being made on January 15, 2020
2. No purchase is necessary to enter. The City of Weyburn Preauthorized Payment program (**PAP**) is a service offered free of charge by the City of Weyburn
3. Each eligible ratepayer registered for the Utility Preauthorized Payment program as of December 15, 2019 will be automatically entered into the Contest draw on January 15, 2020, assuming there has been at least one successful withdrawal made prior to the draw date.
4. Chances of winning the prize are dependent on the number of eligible entries at the time of the prize draw.
5. The Contest is subject to all applicable federal and provincial laws.
6. The City of Weyburn is the sole judge and decision maker regarding any dispute about the application or interpretation of the Rules or any other aspect of the Contest and the judgment or decision of the City of Weyburn will be final.

How to Enter:

Fill out a Preauthorized Payment Form – Utility Account and return with a void cheque to City Hall at 157 –3rd Street NE. Forms can be found by:

*There is no purchase necessary to enter the Utilities Preauthorized Payment Promotional Contest. All new active ratepayers joining the program for utilities, along with existing active utility participants will be automatically entered into the Contest for the prize draw on January 15, 2020.

Eligibility:

The Contest winner must be an active current or existing Utilities Preauthorized Payment program participant as of the draw date for which they have been selected a winner.

The Contest is **not open** to Weyburn City Councilors, management of the City of Weyburn, or members of their family with whom they reside with at the same billing address.

Prize:

The City of Weyburn will draw for the prize on January 15, 2020.

1. Prize drawn for: one (1) prize of a \$250.00 credit to be applied to the winners' Utility account associated with the address on the Preauthorized Payment form.
2. The prize draw will include all active utility ratepayers registered for the Preauthorized Payment program as of December 15, 2019, that have had at least one (1) successful payment withdrawn prior to the draw date of January 15, 2020 .
3. If the winner cannot be reached by written notice or phone call within 14 days of the draw date, they will be deemed to have forfeited their opportunity to win, and a new winner will be chosen.
4. Only the winners selected in the Draw from the Utility Preauthorized Payment Promotional Contest will be contacted by the City of Weyburn.



5. The City of Weyburn will make the final determination of the eligibility of all entries.
6. As a winner, you consent to the publication of your name and photo in various communication platforms as reasonably determined by the City of Weyburn, for a period of 60 days after the Contest. If the winner fails to consent to the publication of their name and/or photo, the prize will be deemed to have been forfeited and a new winner will be chosen.

Prize Redemption and Exchange:

1. All prizes must be accepted as awarded, are not redeemable for cash and are non-transferable.
2. The winner will be notified by way of written notice, and/or a telephone call.
3. The City of Weyburn is the sole sponsor of the Utilities Preauthorized Payment Promotional Contest.
