Resident Business License Fee:

- (1) For resident business paying the fee prior to and including March 15th each year \$50.00
- (2) For resident business paying the fee after March 15th \$75.00
- (3) For new business the fee payable shall be as stated in (1) for a period of forty-five (45) days from start-up of business or invoice date, whichever occurs first, and thereafter the fee shall be as shown in (2).
