A BYLAW TO AMEND SEWER SERVICE BYLAW NO. 2007-3089

The Council of the City of Weyburn, in the Province of Saskatchewan, enacts as follows:

That Bylaw No. 2007-3089 of the City of Weyburn, being a Bylaw to regulate the use of sewer service and the levying of fees or charges in connection therewith, is amended as follows:

1. Schedule A is hereby amended and the attached appendix marked Schedule "A" to Bylaw No. 2007-3089 substituted therefore.
2. This Bylaw shall come into force and effect on the date it receives third reading

4. a)	An additional charge or penalty may be made on all sewer rates and other charges unpaid thirty (30) days following the date of the invoice.	1.5% per month compounded (19.56% annually)
b)	Where an outstanding account is deemed to be uncollectible, an administrative charge may be added to the total to offset legal costs, fees charged by a collection agency and/or municipal costs associated with subsequent collection procedures.	\$100.00
