- To balance the City of Weyburn rate payer's interests with continued growth and prosperity
- To provide a budget that enables growth and balances the Departments' requests to continue to provide a high level of service and programs
- To ensure sustainability today as well as into the future
- To take into consideration the infrastructure gap and set out short and long-term plans addressing the maintenance and replacement of major capital
- To maintain tax policies that keep Weyburn competitive with other Saskatchewan cities
- ♣ The general operations of the City are funded through grants and tax revenue.
- ♣ The utility functions of the City are funded by user fees collected (utility billing, landfill fees, etc) and capital grants.

2020 Highlights

Administration/Finance

- Hospital Levy of \$40 per residence
 - Government of Saskatchewan announced the site for construction of the new hospital
- Municipal Election electing Mayor Roy, Councillor Corrigan, Councillor Janke, Councillor Michel, Councillor Morrissette, Councillor Richards, and Councillor Van Betuw

Police

- Welcomed Police Chief Blunden
- Retirement of Deputy Police Chief Stafford & swore in Deputy Police Chief VanDeSype
- > Swore in three new recruits for 2021

Fire

- Capital purchases included:
 - Extrication equipment
 - SCBA mask washer
 - Ground radios
 - Fire-fighting hose
 - o Rapid intervention kit
- Replace lighting in truck bays to LED

Leisure

- Funding of \$377,625 provided to SE Regional Library
- Provide funding to Weyburn Public Library for programming and facility operations
- Provide \$75,000 in Sask Lottery funding to local organizations



Base Tax Calculation


Three main essential services are used in calculating 'base tax' which is applied to single family properties - residences/condos:

- 1. Police Services (2021 proposed increase of 3.0%)
- 2. Fire Services (2021 proposed decrease of 2.2%)
- 3. Snow removal and street sanding (2021 proposed decrease of 3.1%)

The <u>percentage of the tax levy</u> for a <u>single-family dwelling</u> is applied to the total cost of the three essential services:
