CITY OF WEYBURN FACILITIES PROOF OF COVID-19 NEGATIVE TEST OR VACCINATION GUIDE

Effective November 8, 2021: Residents 18 years of age and older will be required to provide proof of a recognized COVID-19 Vaccination or COVID-19 rapid antigen or polymerase chain reaction (PCR) test result within the past 72 hours, when participating in physical activity or arts programming at City of Weyburn Leisure Services Facilities, or to attend City of Weyburn Council, board, or committee meetings.
