BYLAW NO. 2023-3549A BYLAW TO FIX THE RATES OF TAXATION IN THE CITY OF
WEYBURN FOR THE YEAR 2023

WHEREAS pursuant to Section 253 of the Cities Act a Council shall pass a Property Tax Bylaw annually;
